Collins, T. Parker 77 Motions	Benjamin Lozovsky	Charged with second-degree Murder and additional charges. On September 8, 2024, the defendant allegedly killed Jacklyn Timinski by hitting her in the head with a kettlebell inside an apartment on Shore Drive.

Sizemore, J. Morales 96 Motions	Kenny Victoria	Charged with Attempted Offering a False Instrument in the first degree, second-degree Assault, and additional charges. The defendant, an NYPD Officer, allegedly falsified an accident report in one incident, and hit a person on the head with his radio during an arrest which required stitches.
Castro, A. Parker 77 COC	Skydajah Patterson	Charged with second-degree Murder and additional charges. The defendant allegedly struck Selma Mclean on the head with a pot on March 25, 2024, leading to her death.

Rosen, J. Parker 77 COC	Victor Martinez	Charged with first-degree Robbery and additional charges. On March 5, 2024, the defendant, acting in concert with others, allegedly stole \$100,000 worth of jewelry from a store on Fordham Road after displaying a gun.

Irace, P. Lewis 70 Sentencing	Alieu Jarjou	Found guilty of Attempted Assault in the first-degree and two counts of second-degree Criminal Possession of a Weapon. On January 2, 2022, the defendant fired five times at a vehicle as it drove away.
Carter, J. Parker 77 Motions	Herman Gayle	Charged with second-degree Murder, first--degree Manslaughter, and additional charges. On September 29, 2024, the defendant allegedly shot and killed Devonte Serrano on East 182nd Street.
Singh, N. Hornstein 24 Sentencing	Richie Torres	Pleaded guilty to second-degree Criminal Possession of a Weapon. The defendant shot a 16-year-old boy who allegedly stole his car on April 4, 2023, and wounded a bystander.

<p>Ambrosi, A. Steed 71 Motions</p>	<p>Charles Vilson Elizabeth Allen Marlon Laronde</p>	<p>Charged with first-degree Criminal Sale of a Firearm and additional charges. The defendants acting in concert between June 21, 2023, and April 24, 2024, allegedly purchased guns from out-of-state, brought them to a Bronx autobody shop and removed the serial numbers. 17 firearms were allegedly sold to an undercover police officer.</p>
<p>Namani, B. Parker 77 Motion</p>	<p>Diego Ortega</p>	<p>Charged with second-degree Murder and additional charges. The defendant allegedly stabbed Baraquiel Castelan to death with a knife on February 3, 2024, after the two got into an argument on East 153rd Street.</p>
<p>Evans, S. Lewis DVM Appearance</p>	<p>Dana Barschdorf</p>	<p>Charged with Endangering the Welfare of a Child and additional charges. On January 14, 2025, the defendant who was a paraprofessional at a public school allegedly exposed himself to a group of students.</p>
