Kimmelman, J. Morales 96 COC	Enrique Lopez	Charged with two counts of second-degree Manslaughter and additional charges. On January 21, 2024, the defendant allegedly caused the death of two passengers and severely injured a third passenger after his stunt driving resulted in a crash near Viele and Bryant Avenues.

Miras, J. Clancy 28 Conference	Jayden Rivera	Charged with first-degree Murder and additional charges. The defendant allegedly killed his father, his father's girlfriend, and their 5-year-old son in an apartment in Mott Haven on November 26, 2023.

Sannicandro, R. Steed 71 Motion	Kyshawn Johnson	Charged with Attempted Murder in the second-degree and additional charges. On September 9, 2022, defendant allegedly supplied a gun to a co-defendant who went to the Pelham Parkway Houses and allegedly fired at least 13 times into a crowd. Four innocent bystanders were shot.
Baughman, R. Busching 14 Conference	Papa Diop	Charged with first-degree Rape and additional charges. On August 5, 2024, the defendant allegedly approached a woman near 149th Street and Bergen Avenue and then raped her.
Suminski, G. Clancy 28 Conference	Shaun Pyles	Charged with second-degree Murder and first-degree Manslaughter. The defendant allegedly fatally stabbed Tyquan Person with a knife on March 24, 2023.

Perez, C. Stone 27 Sentencing	Kenneth Hood	Found guilty of Official Misconduct and second-degree Reckless Endangerment. On December 27, 2019, the defendant, was a correction officer on duty at Rikers Island when detainee Nicholas Feliciano tried to hang himself.
Miras, J. Yearwood TRP Motion	Edison Cruz	Charged with second-degree Murder and additional charges. The defendant allegedly shot and killed David Scott and wounded two bystanders on May 3, 2022, after a fight inside a Taco Bell on Jerome Avenue.
Commelin, C. Isales 77 COC	Freddy Flores	Charged with Attempted Murder in the second-degree and additional charges. On the afternoon of March 30, 2024, on East Fordham Road, the defendant allegedly fired a gun five times from across the street. A stray bullet struck a 2-year-old boy in the left hip.

Vega, J. Lewis 70 Appearance	Lillibeth Vasquez	Charged with second-degree Murder, and first-degree Manslaughter. The defendant allegedly crashed into Robert Jimenez on November 26, 2023, who was on a scooter, causing his death.
Baughman, R. Stone 27 Appearance	Tajanhae Brown	Charged with Attempted Assault in the first - degree and additional charges. The defendant allegedly caused her young daughter to become ill by giving her an overdose of prescription medication to treat epilepsy.
Militano, A. McCormack 22 Appearance	Navasia Jones Paul Fine Jr.	Charged with two counts of second-degree Murder and additional charges. The defendant, between August 8, 2021, and August 10, 2021, allegedly acting in concert with her son, took actions leading to the death of her 7-year-old daughter, Julissia Batties.

Ambrosi, A. Isales 77 Sentencing	Dayshawn Bannister	Pleaded guilty to Attempted Murder in the second- degree and additional charges. The defendant stabbed Cheddie Defrietis in the head with a knife on an MTA bus puncturing his brain.
Strout, N. Morales 96 COC	Emmanuel Awah Elias Afflada	Charged with Attempted Murder in the second-degree and additional charges. On January 1, 2024, the defendants acting in concert, allegedly stabbed Carlos Pilliza after he wished them a Happy New Year at the 182nd Street subway station.
